# AMMPARO Ministry Initiative of the Southeastern Minnesota Synod, ELCA (Accompanying Migrant Minors with Protection, Advocacy, Representation and Opportunities)

The ELCA AMMPARO (Accompanying Migrant Minors with Protection, Advocacy, Representation, and Opportunities) initiative is a holistic, whole church commitment to accompany children today and in the future. ELCA adopted AMMPARO at its 2016 Churchwide Assembly in response to witnessing the enormous suffering of children who are forced to flee their Central American communities due to complex and interrelated reasons, including chronic violence, poverty, environmental displacement and lack of opportunities. The ELCA, through its synods' companion partnerships in Guatemala, El Salvador, and Honduras, is well-positioned to help ensure that these vulnerable children are protected. Synods throughout the ELCA are partners in this ministry, creating ministry opportunities based on their local contexts.

The Southeastern Minnesota Synod, ELCA, has engaged in the AMMPARO ministry since late 2016. Some current ministries include:

- Partnering with local and national organizations in relationship with migrant minors and their families
- Accompanying 'Welcoming Congregations' and local AMMPARO Network congregations and individuals
- Coordinating and leading border immersion visits for congregations and individuals
- Sharing the story of migrant minors through
  - o Adult forums / Temple Talks / Sermons
  - Webinars
  - A Migrant Journey (virtual Confirmation and/or adult education interactive experience)
  - Book and Bible studies
- Connecting congregations and individuals with local and national resources
- Accompanying synod congregations in their local ministry initiatives
- Providing essential supplies for refugee children in faith-based borderland shelters
- Advocating for just, Gospel-focused local, state and national policies and initiatives

Adult Basic Education (ABE) is a state-wide system that serves adults who are working towards a high school credential, learning English, improving basic skills such as literacy and math, and/or preparing for post-secondary education or employment. ABE is funded with both federal and state funds, and services are delivered through a network of 39 consortia comprising all Minnesota school districts as well as other partners including the correctional system and community-based organizations.

The mission of ABE in Minnesota is to provide adults with educational opportunities to acquire and improve the literacy skills needed to become self-sufficient and to participate effectively as productive workers, family members, and citizens.

#### **Statistics and Impact**

In program year 2019-2020, approximately 56,000 individuals were served in ABE programs across the state. These students accrued more than 4 million contact hours.

#### **Eligibility**

To be eligible for ABE, an individual must be:

age 17 or older and not enrolled in or required to be enrolled in any school in the K-12 system.

And must meet one or both of the following criteria:

- lacks a secondary (high school) credential
- functions below the 12th grade level in any of the basic academic areas including reading, math, and ability to read, write and understand English.
